You are signing up for a 10-month contract from September until the end of June. You are taking a spot in a class therefore you are responsible for that spot for a 10-month period. We do allow for a 4-month grace period. Please read the conditions below and sign at the bottom. If you have any questions, please ask prior to signing this form.

- Please make all cheques payable to 'Dance Extreme Inc.'
- There will be a service charge of \$45.00 for every returned or NSF cheque.
- If 3 cheques are returned, Dance Extreme will no longer accept your cheques and other means of payment will be required immediately.
- The registration fee of \$25.00 as well as automatic withdrawal or full payment MUST BE SUBMITTED at the time of registration. The registration is not complete until it is submitted.
- **The registration fee is non-refundable.**
- If you discontinue at any time or any reason a signed letter is required to notify Dance Extreme.
- Prior to December 21st, letters received prior to the 15th of the month will have all months to follow refunded.
- Prior to December 21st, letters received after the 15th of the month will be responsible for the following month payment, all months to follow refunded.
- **No refunds for classes after December 21, 2007.**
- Every year we have a year-end performance in June. There is a \$50.00 costume deposit due at the time of registration but can be post-dated for November 30, 2007. The balance owing on the costume is paid when the costume is picked up.
- Costume deposits must be submitted at the time of registration or a letter stating that your child will not be participating in the recital. The registration is not complete until it is submitted.
- Costume deposits will not be accepted after November 30, 2007.
- The maximum for costumes is as follows:
 - Creative Movement, Pre-Dance, Pre-Primary, Primary, Grade 1, Grade 2 and all Junior classes - \$65.
 - Grade 3, Grade 4, and all Intermediate classes - \$75.
 - Grade 5 and above, and all Teen and Senior classes - \$80.
- If any monies are outstanding your child will not be permitted to dance in the year-end show.
- Costume deposits are non-refundable after November 30, 2007. They may be transferred to another class included on this registration form if the costume has not been ordered.
- Costume deposits are non-transferable after December 21, 2007.
- Students must be taking 2 graded ballet classes a week to be considered for ballet exams.
- Exam students are chosen at the teacher's discretion.
- Students in Grade 3 and above must take a minimum of 2 ballet classes per week.
- Students wanting to take Pointe must receive permission from the ballet teacher. They must be taking 2 ballet classes per week along with their Pointe class.
- In order for dancers to participate in dance classes, dancers must have proper dance attire including clothing and shoes.
- All classes are broadcasted in the front lobby. Teachers may record parts of a class to be used as a teaching tool.
